Mine Eyes Have Seen Thy Salvation

Then the Righteous Simeon takes the forty day old infant Jesus in his arms, he pronounces him the Christ: "A Light to lighten the Gentiles and the glory of thy people Israel" (cf. Luke 2:29-32). With these words, we conclude our forty day celebration of God's revelation to us in His Son: as Man, as Trinity, as Messiah. Each aspect of His manifestation is essential for us to understand who Jesus is and thereby understand what He has come into the world to do. Jesus is not revealed to us as prophet, or teacher or rabbi; rather as Saviour, God-with-Us, Emmanuel, the Son of God, the Anointed-one, that is, the Christ.

Simeon's blessing, the song that we sing daily at Vespers, is a thanksgiving that God allowed him to live long enough to see that day, i.e. the Coming of the Lord. Yet it is also an ominous prophecy—a warning—that the child was "appointed for the fall and rising of many in Israel, and for a sign that would be opposed" (*Luke* 2:34).

God's manifestation to us is at the same time both a joy and a warning. It is a joy because the prophecies of the Messiah's coming have been fulfilled. It is a warning because the Messiah comes to set things right. And woe be to those who think they already are.

Our joy ends, therefore, on a somber note. It foreshadows the Cross and the pain of the Mother of God personally at her son's crucifixion (*Lk.* 2:35):

Then the Righteous Simeon takes the Simeon could die in peace but Mary would follow forty day old infant Jesus in his arms, he her son to the Cross.

God has come in the flesh; this Jesus is God's own Son, this is the Messiah, promised of old. We celebrate this trifold manifestation of Who He is. But now we look to the Cross; we await His Passion and His Resurrection. Only then will the purpose of His revealing to men be made clear, why He has come into the world.

Let us open our eyes to behold His purpose and like Simeon, bless God saying: "Mine eyes have seen thy salvation," beholding Christ in our hearts, and in our lives, as the Elder did in his arms.

When Conscience Calls Us to Act by Fr. Basil Biberdorf

A challenge arising from the Patient Protection and Affordable Care Act (a.k.a. "Obamacare") is the determination from the Department of Health and Human Services (HHS) that private companies are obligated to provide all contraceptives described by the Act. These include contraceptives that act, or have the potential to act, as abortifacients (i.e., they cause abortions). Some of these companies with leaders guided by Christian beliefs have responded with legal action. The most prominent of these is Hobby Lobby, a chain of arts and craft stores, but closer to home the law has also been challenged by Conestoga Wood Specialties based in East Earl, Pennsylvania.

Conestoga is of particular interest to the Chapel of the Holy Spirit because one of the two plants they operate in Snyder County is in Beavertown across the street from our Chapel's lot. Conestoga's corporate leaders are part of a Mennonite group that rejects abortifacient birth control and have chosen to omit such coverage for their employees as a matter of conscience. In early December, Conestoga announced their intent to oppose the HHS mandate and initiated legal action, hoping to avoid \$95,000 per day in penalties. After an initial injunction, the U.S. District Court in Philadelphia ruled against Conestoga in January. Conestoga is appealing the decision.

What does this mean for us? For starters, as Orthodox Christians, it is not necessary for us to affirm Mennonite teaching in order to stand with opponents of this mandate on the basis of conscience. The mandate to pay for abortion-causing drugs is giving offense to the corporate leaders of Conestoga Wood Specialties just as it should to every Orthodox Christian, business owner or not. Indeed, even the priests who paid Judas for his betrayal knew that claiming Judas was

the one who actually committed the act would not absolve them of their complicity (cf. *Matthew 27:6*). It is impossible for us as Christians to believe that the only guilty ones are those who *use* the deadly drugs, and not also those who, under compulsion of the law, *paid* for them for that *specific purpose*.

What can we do? I have sent a letter on behalf of the Chapel of the Holy Spirit to Andrew Hahn, the president of Conestoga Wood Specialties, expressing our support for their decision to hold to their conscience and a willingness to help as we can. The Chapel now has a regular litany petition for those enterprises and individuals pursuing civil disobedience for the sake of upholding the sanctity of life, which is consistent with historic Christian practice. The early Christians, when ordered to sacrifice to the emperor as though he were a god, professed their loyalty to the empire but refused to worship any but the True God. Many became
