# **Site Survey: October Update**

n the Psalms, the Holy David sings to us, "behold, how good and how pleasant it is for brethren to dwell together in unity" (Ps 132:1). Truly, it is good and pleasant, and I can express my sincere pride in our community after our initial parish meeting with K&W Engineers and Hoffman Leakey Architects last month. We dwelt together in unity of heart and expressed a number of points of view regarding our future callings in ministry, some of which probably can be fit together and others of which might not be able to be fit together. The key takeaways that I personally observed from our meeting were: (1) we do not believe we have sufficient worship space, fellowship space, or classroom space in our present facilities, (2) there is a strong desire in the parish to be more family friendly through more outside gathering/recreation/play space, (3) there is a strong desire in the parish for an Orthodox cemetery and more

traditional funerary practices, (4) there is a desire for an improved parking situation, and (5) there is a general acknowledgement that we need to do more to help individuals with disabilities attend and participate in our services.

In addition to these general takeaways, K&W presented us with a number of concrete challenges that we will face in terms of modifying our present facilities. (1) Our building footprint is "maxed out" at 119 S. Sparks St per borough code. (2) Trinity House (123 S. Sparks St) is registered with the Holmes Foster Historical District as a historical building, and so modifying its exterior or replacing it may prove difficult. (3) The gravel parking lot at 123 S. Sparks St is "grandfathered" and not in compliance with borough regulations, so we cannot pave it in its present configuration, and likely would

#### **October Adult Education**



## **Liturgy of St. James**

As the Feast of St. James "the Lord's Brother" falls on Sunday, October 23rd this year, we have been blessed by His Eminence to celebrate the ancient "Liturgy of St. James" in place of the Liturgy of St. John Chrysostom on this day. The Liturgy of St. James was the typical parish liturgy of Jerusalem, Palestine, Mount Sinai, Georgia, and parts of the Levant from the 4th century until the time of the Crusades and was prayed almost daily by great saints of the Church such as Cyril of Jerusalem, Sabbas the Sanctified, and John Climacus. Through their prayers may God bless this occasion for the upbuilding of His holy Church.

## "Prayer of the Veil," Liturgy of St. James

We thank Thee, O Lord our God, that Thou hast given us the freedom of entry into the holy place by the blood of Jesus, inaugurating for us a new and living way through the veil of his flesh. Having therefore been counted worthy to enter the place where Thy glory dwells, and to be within the veil, and to look upon the Holy of Holies, we fall down before Thy goodness, O Master. And having uncovered the veils of the mysteries that symbolically surround this sacred rite, show us clearly, and fill our spiritual vision with Thy boundless light; and having cleansed our poverty from all defilement of flesh and spirit, make it worthy of this dread and fearful presence.

In order to move into compliance with federal tax law, we have separated out Fr. Ignatius' portion of the "payroll tax" and pay it out differently on his paystub.

need to reduce its size in order to pave it. It is possible that by dialogue with the borough and the historical district, all of these problems may be navigable, but to say it concisely, modifications to our present facilities are likely to prove challenging. One additional bright spot, however, is that K&W's initial analysis indicates that we should not have any trouble combining the two parcels into one unit, which could be helpful in any number of ways *vis-a-vis* borough regulations.

So it seems we have a lot of challenges ahead of us, but we should certainly not lose heart, for it is written, "greater is He who is in you than he who is in the world" and again, "all things work together for good to them that love God, to them that are called according to His purpose" (1 Jn 4:4; Rom 8:28). It is clearly our purpose, brothers and sisters, to build up the Church in this place; we can say that dogmatically. Our next community meeting with K&W and Hoffman Leakey is on Monday, October 17 at 6pm. I encourage everyone to attend and to share ideas, that God might use us to work wonders in this place. Glory to Jesus Christ!
